The Nominating Committees will receive a list of members in their district, which will be of assistance in seeking nominations. The committee members

are to nominate two candidates for each trustee position of their respective districts and proposed candidates should be contacted prior to the committee meeting to determine their willingness to serve on the board. All Nominating Committee meetings will be held at the Flint Hills RECA office, 1564 S. 1000 Rd, Council Grove, on Thursday, Jan.3, 2019 at 11:30 a.m.

Nominations for a qualified candidate may also be made by petition, filed at the Council Grove office on or before the close of business on the fifteenth (15th) day following the nomination committee's selection of trustee nominees. Board President Awarded Certificates

For cooperatives to thrive in this time of change, it's vital that directors have a solid understanding of the electric cooperative business model, a diverse set of knowledge and skills, up-to-date knowledge of industry changes, and a commitment to learning throughout their service on the board. The National Rural Electric Cooperative Association (NRECA) offers education programs for electric cooperative board members and awards certificates when board members have completed the certificate programs. The Credentialed Cooperative Director (CCD) program includes five courses: Director Duties and Liabilities, Understanding the Electric Business, Board Operations and Process, and Strategic Planning and Financial Decision Making. The Board Leadership (BL) program consists of the following courses: Grassroots, Power Supply, Cooperative Business model, Governance Financial, Communications, and Technology and Risk Management. Completing these certificate programs demonstrates the ongoing commitment by directors to advancing their knowledge and performing their fiduciary duty to the best of their ability.
