FROM THE MANAGER

2021 Year in Review

The Board of Trustees and the staff of Flint Hills Rural Electric Cooperative Association (Flint Hills REC), extend this invitation to you to attend Flint Hills REC's 84th annual meeting.

I know it has been a long three years since we last met, and we are looking forward to seeing you, our consumer-members. The meeting provides you the opportunity to become more informed on the programs and activities of your electric cooperative and allows the board and staff to engage with you and obtain your feedback.

Year in Review

2021 still saw us dealing with the COVID-19 pandemic and because of that our board decided to cancel our 2021 annual meeting. However, we still held our trustee elections via mail-in ballot. On the ballot in 2021 were several bylaw changes that were passed. One change dealt with the annual meeting and now allows us the ability to hold our annual meeting anytime in a calendar year.

Last February, we faced Winter Storm Uri. This storm brought bitterly cold temperatures as far south as Texas. These cold temperatures had a large effect on our power supply, specifically wind and natural gas. Flint Hills REC along with the other members of Kansas Electric Power Cooperative (KEPCo), our power supplier, were able to minimize

the cost impact this storm had on power costs to our consumer-members.

Safety

Safety continues to be a top priority for our employees, consumer-members and communities. In 2021, Flint Hills REC received a No Lost Time award at the Kansas Electric Cooperative's Annual Meeting. We are very proud of our employees for achieving this award, which proves that our efforts of making safety a priority do pay off.

Even though we were unable to take our safety demonstration trailer out to the communities in 2021, we continued to provide electric safety information to our members through the *Kansas Country Living* magazine, our website and our Facebook page. Employees are trained to look for opportunities to keep our electric distribution system safe for those that live, work and play in the communities we serve. Monthly employee safety meetings and daily job briefings are constant reminders to the employees of the safety sensitive tasks they must perform each day.

Financial Update

Flint Hills REC continues to meet all financial requirements of the cooperative's lenders. Total margins for 2021

were \$721,323, up from \$330,953 in 2020. The 2021 margins were aided by the forgiveness of the Payroll Protection Program loan in the amount of \$567,500. On Dec. 31, 2021, member equity was \$20.7 million, or 55.1% of total assets. In January 2022, the board of trustees approved payment of \$459,711 of capital credits to the Flint Hills REC membership in March.

Reliability

We are always looking at ways to enhance our system's reliability. We use total minutes off per meter to analyze how we are doing. The USDA Rural Utility Service reliability guidelines recommend outage time be less than 200 minutes/meter/year. We are proud to say that in 2021 Flint Hills REC was at 76 minutes/meter/year. It is important to understand that these numbers are used to determine the overall health of Flint Hills REC's electric distribution system, and these numbers exclude power supply outages, major events and scheduled outages. There are many factors that contribute to this success such as the efforts of our employees to maintain and update our system, response time to outages, tree trimming and pole inspections to name a few.

We always look forward to seeing our members and hope you can join us at your annual meeting on March 29, 2022.
